### **PET POLICY**

1. I understand that the nightly fee is \$20 per pet (Maximum of two pets per room) in addition to the Resort's nightly rate if applicable. Maximum weight per pet is 65 lbs.
2. I understand and authorize that my credit card will be charged for any hotel damage that may result or is caused by my pet during my stay (#11 below). In lieu of a credit card authorization, I will provide the Resort with a \$250 cash deposit that will be returned to me upon checkout after my room has been inspected and cleared by hotel personnel.
3. I understand there are certain areas of the Resort where pets are not allowed, which include the Restaurants, Pool Area, Spa, Meeting Rooms and Lounge.
4. I understand that I will be issued a "Pet In Suite" sign to display on the outside of my suite door to alert hotel personnel of my pet in residence. I will pay a \$5.00 fee for this sign if not returned to the Front Desk upon checkout.
5. I understand the Resort prefers that no pet be left unattended in the room. If I leave my pet in my room unattended, I will provide the Front Desk with a contact number where I can be reached should my pet create a disturbance, become agitated or need immediate attention.
6. I understand and agree to use the designated pet areas to walk my pet and will use the mutt mitts to clean up my pet's waste and that my pet must be on a leash at all times in public areas.
7. I understand that if my pet is left unattended in the room, Housekeeping will not clean my room due to safety concerns for the employees and the pet. Subject to staff availability, I must request service while I am in attendance with my pet.
8. I understand that the issued "Premiere Pet Club" tag must be used when walking my pet on property so my pet/s can be identified as registered Premiere Pet Club Members.

9. I understand that aggressive behavior, excessive barking, howling (noise) or other pet behavior that disturbs or interferes with other guests' safety and enjoyment will result in immediate removal of my pet to a local kennel at my expense.

10. I agree to indemnify, hold harmless, and defend the Resort, its owners, agents and employees from any and all liability, claims, losses, costs, and expenses, (including reasonable attorney's fees) arising out of or relating to any claim for personal injury or property damage caused by my pet.

11. I understand and agree to be held personally liable for any and all damages caused by my pet to the Resort property or room contents and acknowledge the below fees if applicable.
